(pharmacy practice in the 5th year of study)

# Conditions for passing a course in the academic year 2023-2024 (Autumn 2023)

Internship II – 24 weeks is a compulsory course for students in the 5th year of study.

Internship II (pharmacy practice) duration is 24 weeks of in-service training in a pharmacy open to the public or hospital. At the beginning of the internship, students will get acquainted with pharmacy personnel, division of labor in pharmacy, work safety regulations, pharmacy operating rules, pharmacy sanitary regimen, and concerning legal regulations. Also, adequate knowledge of legal and other requirements associated with the pharmacy practice (the preparation and dispensing of medicinal products) is necessary.

## Place of performing pharmacy practice

- Pharmacy public pharmacy, hospital pharmacy
- Maximum three various pharmacies
- Minimum two weeks of practice in a Czech pharmacy

#### Start of pharmacy practice

- after obtaining 200 credits (the same number of credits as required for enrolment to the 5th year of study)
- possible start of the pharmacy practice (summer 2023):3. 7. 2023
- registration a course FASM1\_11 Internship II 24 Weeks in IS (Information System): in July/August 2023

## **Ending pharmacy practice**

#### State exams in June 2024:

deadline for the ending of pharmacy practice:
 9. 2. 2024 (ideally earlier, in January 2024)

deadline for receiving credits (writing the credit test):
 16. 2 .2024

#### State exams in January 2025:

deadline for the ending of pharmacy practice:
 31. 10. 2024 (ideally earlier)

deadline for receiving credits (writing the credit test):
 15. 11.2024

## **Duration of pharmacy practice**

- 24 weeks
- one week = 5 working days, 8 hours a day
- public holidays are considered working days
- a student is asked to bring working clothes and shoes with him/her

## Documents necessary to the course Internship II - 24 weeks

The document **The Scope of Pharmacy Practice** includes guidelines for pharmacy activities that should be performed during pharmacy practice.

## Before starting pharmacy practice

Before starting practice in a pharmacy, The Paper of Acceptation is necessary to fill in

an agreement that the student of the Faculty of Pharmacy of Masaryk University will perform (part of)
 his/her pharmacy practice in the pharmacy in the agreed term

Filled in The Papers of Acceptation (requested are only original Papers with stamps and signatures of pharmacy advisors) should be delivered before starting a pharmacy practice to:

In the case of a pharmacy change, the new The Paper of Acceptation must be filled in and delivered. Before starting a practice in a Czech pharmacy, filling in and delivering The Paper of Acceptation is also necessary.

### After ending pharmacy practice

After finishing practice, a pharmacy advisor makes a record to Confirmation of completion of pharmacy practice

a summary of the student's approach to working in a pharmacy

### Insurance for damages during pharmacy practice

Masaryk University does NOT have insurance against damage caused by a student to a third party or if a third party (pharmacy) causes damage to a student. Responsibility for pharmacy practice is governed by the Labour Code (Section 391). The Labour Code states that liability for damage is the relationship between the student and the provider of practice.

For this reason, I give you to consider and recommend that you ensure for the duration of the pharmacy practice commercial insurance of compensation for damage caused in connection with the practice in a pharmacy (liability for damages and injuries caused to a third party, damage or injury caused to the student).

## Conditions for receiving a credit from the course Internship II - 24 weeks

- the accomplishment of 24 weeks of pharmacy practice
- the record of fulfilled pharmacy practice given by a pharmacy advisor in Confirmation of completion of pharmacy practice
- working out Daily Paper of Pharmacy Practice
  - o after finishing the pharmacy practice, please send it in an electronic version by e-mail to: mazankovad@pharm.muni.cz (at the latest until one week before the writing of the credit test)
- the filling in a questionnaire from each country where pharmacy practice was performed
  Pharmacy practice of students from Brno Pharmaceutical Faculty (MU) in the EU countries
- successful passing a credit test
  - o the date and time of a credit test will be announced continually during the academic year (according to the needs of students finishing the course FASM1\_11 Internship II 24 Weeks)
  - o minimum one week before the date of passing a credit test, the following documents must be delivered to Dr. Mazankova:
    - the electronic version of the worked-out Daily Paper of Pharmacy Practice
    - Confirmation of completion of pharmacy practice from all pharmacies
    - the filled-in questionnaire
