### Evaluation of the applicant's scholarly/artistic qualifications

Associate professor Libor Ustohal has worked at the Department of Psychiatry, School of Medicine, Masaryk University and University Hospital in Brno, Czech Republic continuosly since 2005 on. Consequently, he got his Ph.D. and Associate Professor's degrees. From 2008 to 2010, an assistant at the Faculty of Medicine of Masaryk University. From 2011 to 2017 Assistant Professor at the Central European Institute of Technology (CEITEC-MU). From 2011 to 2017, an assistant professor at the Faculty of Medicine of Masaryk University. From 2018 to 2019 Associate Professor at the Central European Institute of Technology (CEITEC-MU). Since 2018, he has been an associate professor at the Faculty of Medicine of Masaryk University. His most frequently quoted scientific works are related to transcranial magnetic stimulation in neuropsychiatry and the first episode of schizophrenia. Libor Ustohal collaborates with research centers in Germany (rTMS) and Slovakia (stress hormones in schizophrenia). As of Libor Ustohal 's activity in the field of biological psychiatry, he has been the member and scientific secretary of the Executive Committee of the Society of Biological Psychiatry, Czech Republic since 2013 on. He has also been the President of the Section of Biological Psychiatry, Psychiatric Association ČLS JEP, Czech Republic since 2017 on.

**Conclusion**: The applicant's scholarly/artistic capabilities **meet** the requirements expected of applicants participating in a professor appointment procedure in the field of Psychiatry.

#### Evaluation of the applicant's pedagogical experience

He teaches medical students in psychiatry in the Czech as well as English languages. His primary area of scientific interest is repetitive transcranial magnetic stimulation and other neurostimulation methods in the treatment of mentally ill people, as well as psychopharmacotherapy. University activities Supervisor of postgraduate studies in the field of Psychiatry and Psychiatry Member of the Departmental Committee of Psychiatry and Psychiatry of the Medical Faculty of Masaryk University Member of the Ethics Committee for Research (EKV) of Masaryk University (2015-present).

**Conclusion**: The applicant's pedagogical capabilities **meet** the requirements expected of applicants participating in a professor appointment procedure in the field of Psychiatry.

### Evaluation of the applicant as a respected and recognized scholarly or artistic figure in a given field

Libor Ustohal is a successful mentor in the Ph.D. study in the field of psychiatry at his institution, but is also involved in the boards of the Ph.D. study at the university departments of psychiatry in Hradec Kralove and Olomouc. He is an active member of the European College of Neuropsychopharmacology (ECNP) Till the date 9. 6. 2021 doc. Ustohal is the author or co-author of 34 original scientific articles, of them in journals with impact factor. In 12 of them doc. Ustohal is the first or corresponding author. Associate professor Ustohal further published partial results of his research activity on 4 abroad and 3 domestic conferences. Response to scientific work of associate professor Ustohal includes 236 citations (without auto-citations) listed in the WOS database. The total H-index of associate professor Ustohal according to WoS is 10.

**Conclusion**: The applicant **is** a respected and recognized scholarly figure in his/her field. The applicant **has** made a significant contribution to the development of his/her field. The applicant **constitutes** a leading figure in his/her field of scholarship or research.
