

FASM1 Internship II - 24 Weeks

(pharmacy practice in the 5th year of study)

Conditions for passing a course in academic year 2020-2021

Internship II – 24 Weeks is a compulsory course for students of the 5th year of study.

The duration of the Internship II (pharmacy practice) is 24 weeks of in-service training in a pharmacy open to public or in a hospital. In the beginning of the internship, students will get acquainted with pharmacy personnel, division of labour in pharmacy, work safety regulations, pharmacy operating rules, pharmacy sanitary regimen and concerning legal regulations. Also adequate knowledge of legal and other requirements associated with the pharmacy practice (the preparation and dispensing medicinal products) is necessary.

Place of performing pharmacy practice:

- Pharmacy - hospital pharmacy, public pharmacy
- **Maximum 3 various pharmacies**
- **Minimum 2 weeks of practice in a Czech pharmacy**

Possible start of pharmacy practice:

- after obtaining **200 credits** (the same number of credits as required for enrolment to the 5th year of study)

Registration (enrolment) in a course FASM1 Internship II – 24 Weeks (into Information System):

- after obtaining **200 credits**

Duration of pharmacy practice: **24 weeks**

- It is possible to count in 2 accomplished weeks of pharmacy practice:
– a course: **FARP1 Internship I – 2 Weeks** (selective course)

In the case of accomplishment of above-mentioned pharmacy practice course (2 weeks), the duration of pharmacy practice in the 5th year of study is only **22 weeks**.

- One week = 5 working days, 8 hours a day
- Public holidays are considered as working days
- A student is asked to bring working clothes and shoes with him/her

Documents necessary to the course *Internship II - 24 Weeks*:

Before starting practice in a pharmacy, „The Paper of Acceptation“ is necessary to fill in (agreement, that the student of the Faculty of Pharmacy of the Masaryk University will perform (part of) his/her pharmacy practice in the pharmacy in the agreed term).

Completely filled in Papers of Acceptation (requested are only original Papers with stamps and signatures of pharmacy advisors) should be delivered before starting a pharmacy practice to:

- course guarantor: PharmDr. Bc. Dana Mazankova, Ph.D. (send to: mazankovad@pharm.muni.cz), or
- secretary of Dpt. of Applied Pharmacy – Mrs. Blanka Číhalová

In the case of change of pharmacy, a new Paper of Acceptation with a new pharmacy must be filled in and delivered to Dr. Mazánková or secretary Dpt. of Applied Pharmacy.

Before starting a practice in Czech pharmacy, it is also necessary to fill in and deliver Paper of Acceptation to Dr. Mazánková.

After finishing practice both in home and Czech pharmacy, ask your pharmacy-advisor to make record to „[Logbook of Internship II - 24 Weeks](#)“.

Guidelines for pharmacy activities which should be performed during the pharmacy practice are included in „[The Scope of Pharmacy Practice](#)“.

Conditions for receiving a credit from the course *Internship II - 24 Weeks*:

- the accomplishment of **24 (22) weeks of pharmacy practice**
- the record of fulfilled pharmacy practice given by a pharmacy advisor in „[Logbook of Internship II - 24 Weeks](#)“
 - description of all activities performed by a student during his/her pharmacy practice by a pharmacy-advisor, summary of student`s approach to work in a pharmacy
 - it is necessary to print out the Logbook before starting the pharmacy practice and than during the practice let your pharmacy-advisors make reports into it
- working out „[Daily Paper of Pharmacy Practice](#)“
 - after finishing the pharmacy practice, send it in electronic version by e-mail to: mazankovad@pharm.muni.cz (at the latest untill one week before writing of credit test)
- the filling in a **questionnaire** from each country where pharmacy practice will be performed – “[Pharmacy practice of students from Brno Pharmaceutical Faculty \(MU\) in the EU countries](#)”
- successfull passing a **credit-test**
 - the date and time of a credit-test will be announced continually during the academic year (according to needs of students finishing the course *FASM1 Internship II - 24 Weeks*)
 - minimum one week before a date of passing a credit-test, following documents must be delivered to Dr. Mazankova:
 - electronic version of worked-out „[Daily Paper of Pharmacy Practice](#)“
 - printed version of „[Logbook of Internship II - 24 Weeks](#) „ with records from pharmacy-advisors from all pharmacies (pharmacy in home country, pharmacy in the Czech Republic), where a pharmacy practice where performed
 - the filled-in **questionnaire**
