

Measure of the Faculty of Pharmacy of Masaryk University No. 2/2021

Determination of the amount of fees associated with the study for the academic year 2021/2022

(As amended effective from September 1, 2021)

Pursuant to Section 28, Paragraph 1 of Act No. 111/1998 Coll., On Higher Education Institutions and on Amendments to Other Acts (Act on Higher Education Institutions), as amended (hereinafter referred to as the "Act on Higher Education Institutions"), I issue this measure:

Article 1

Determination of the amount of fees for operations related to the admission procedure

- (1) Pursuant to the provisions of Section 58, Paragraph 5 of the Act on Higher Education Institutions and Article 5 of Annex No. 2 to the Statute of Masaryk University (hereinafter the "MU Statute"), I determine the amount of fees for admission according to Paragraph 1 of the Act on Higher Education Institutions and Article 3 of Annex No. 2 to the MU Statute as follows:

Bachelor's and non-follow-up Master's degree study programme	Follow-up Master's degree study programme	Doctoral study programme
CZK 700	Does not open	CZK 600

- (2) Pursuant to the provisions of Section 58, Paragraph 5 of the Act on Higher Education Institutions and Article 5 of Annex No. 2 to the MU Statute, I set the amount of fees for admission to study in a foreign language for the academic year 2021/2022 pursuant to Section 58, Paragraph 4 of the Act on universities and Article 4 of Annex No. 2 to the MU Statute as follows:

EUR 30	Does not open	EUR 30

Article 2

Determination of the amount of fees for study in a study programme conducted in a foreign language

- (1) Pursuant to the provisions of Section 58, Paragraph 5 of the Act on Higher Education Institutions and Article 13 of Annex No. 2 to the MU Statute, I set the amount of fees for study in a study programme conducted in a foreign language for the academic year 2021/2022 pursuant to Section 58, Paragraph 4 of the Act on Higher Education Institutions and Article 12 of Annex No. 2 to the MU Statute as follows:

The amount is given for one academic year.

- (2) The amount of the fee for study in study programmes accredited in a foreign language, determined by this measure, is valid for students starting their studies in the academic year 2021/2022.
- (3) The amount of the fee for students enrolled in studies before the effectiveness of this measure shall be determined according to the amount of the fee valid at the time of their enrolment.

Article 3

Determination of the amount of fees for the assessment of the fulfilment of the conditions for admission to study according to § 48 paragraph 4 letter d) and paragraph 5 letter c) of the Act

- (1) Pursuant to the provisions of Section 48, Paragraph 7 of the Act on Higher Education Institutions and Article 15 of Annex No. 2 to the MU Statute, I set the amount of the fee for the academic year 2021/2022 for operations connected with paragraph 4 letter d) and paragraph 5 letter c) of the Act and Article 14 of Annex No. 2 to the Statute as follows:

Article 4
