

## Measure of the Faculty of Pharmacy, Masaryk University No. 5/2020

## Fees for Advanced Master's Proceedings

(as amended from 5 September 2022)

In accordance with Section 46(5) of Act No. 111/1998 Coll., on Higher Education Institutions and on Modification and Amendment of Other Acts (Higher Education Act), as later amended (hereinafter referred to as the "Act"), and in accordance with the Study and Examination Regulations of Masaryk University (hereinafter referred to as the "Regulations"), I issue the following Measure:

## Article 1

Determination of fees for Advanced Master's Proceedings in the Czech and English degree programmes at the Faculty of Pharmacy, Masaryk University

- (1) In accordance with section 46(5) of the Act, the fixed fees of the faculty for acts connected with the acceptance of the application for the advanced Master's state examination and with the organisation of this examination in the Czech language amount to CZK 8,800, and in the English language to EUR 1,900. This basic fee includes the administration of the advanced Master's proceedings, the initial consultation with the chair of the advanced Master's examination board, the organisation of the advanced Master's state examination, the provision of reviewers and the defence of the advanced Master's thesis, and the organisation of the graduation ceremony.
- (2) Applicants who request a professional consultant shall pay, in addition to the basic fee, CZK 8,000 for consultations in Czech, and EUR 500 for consultations in English proceedings. The fee includes consultations with a selected expert in the field and a final revision of the advanced Master's thesis before its submission.
- (3) Applicants who request a professional consultant and at the same time use of instrumentation and laboratory equipment of the faculty, shall pay CZK 14,000 in Czech, and EUR 1,000 in English proceedings. As part of the fee, the candidate shall not only have the opportunity to use the faculty's equipment and laboratories for their research, but also professional guidance in the experimental and theoretical part of the thesis, including the final revision of the thesis before its submission.
- (4) The fee for a resit of the advanced Master's exam or part thereof in Czech is CZK 2,000; for a resit in English it is 200 EUR. The resit fee must be paid no later than 7 working days before the date determined for the resit of the advanced Master's examination on the basis of an invoice issued by the Finance Office of the Faculty of Pharmacy.
- (5) The fees can be paid through the Shopping Centre in the Information System of Masaryk University.

## Article 2 Final provisions

(1) This Measure repeals the Measure of the Faculty of Pharmacy of Masaryk University No. 5/2020 "Fees for Advanced Master's Proceedings" of 9 February 2021 and enter into force and into effect on 5 September 2022.
