

**Determination of the Amount of Fees Associated with
Studies for the Academic Year 2022/2023**

(As amended with effect from 1 September 2022)

Pursuant to Section 28(1) of Act No. 111/1998 Coll., on Higher Education Institutions and on Amendments and Additions to Other Acts (the Higher Education Act), as amended (hereinafter referred to as the "Higher Education Act"), I issue the following measure:

Article 1

Determination of the Amount of Fees for the Admission Procedure

- (1) Pursuant to the provisions of Section 58(5) of the Higher Education Act and Article 5 of Annex 2 to the Statutes of Masaryk University (hereinafter referred to as the "MU Statutes"), I hereby set the admission fees for the academic year 2022/2023 in accordance with Section 58 (1) of the Higher Education Act and Article 3 of Annex 2 to the MU Statutes:

- (2) Pursuant to the provisions of Section 58 (5) of the Higher Education Act and Article 5 of Appendix No.2 of the MU Statutes, I am setting the amount of fees for admission to study in a foreign language for the academic year 2022/2023 in accordance with Section 58(4) of the Higher Education Act and Article 4 of Appendix No.2 of the MU Statutes:

Article 2

Determination of the Amount of Fees for Study in a Study Programme Conducted in a Foreign Language

- (1) Pursuant to the provisions of Section 58(5) of the Higher Education Act and Article 13 of Appendix No.2 of the MU Statutes, I am setting the amount of fees for study in a study programme conducted in a foreign language for the academic year 2022/2023 in accordance with Section 58(4) of the Higher Education Act and Article

12 of Appendix No.2 of the MU Statutes: Bachelor's and non-continuing Master's degree programme	Postgraduate Master's degree programme	Doctoral study programme
7000,- EUR	It doesn't open	0,- CZK

The amount is for one academic year.

- (2) The amount of the fee for study in study programmes accredited in a foreign language, set by this measure, is valid for students starting their studies in the academic year 2022/2023.
- (3) The amount of the fee for students enrolled prior to the entry into force of this measure shall be set according to the fee applicable at the time of their enrolment.

Article 3

Determination of the Amount of Fees for the Assessment of Admission to Study Pursuant to Section 48 (4) (d) and (5) (c) of the Act

- (1) Pursuant to the provisions of Section 48(7) of the Higher Education Act and Article 15 of Appendix No.2 of the MU Statutes, for the academic year 2022/2023, I am setting the amount of the fee for acts related to the assessment of compliance with the conditions for admission to study pursuant to Section 48(4) (d) and (5) (c) of the Act and Article 14 of Appendix No.2 of the Statutes:

Article 4

Final Provisions

- (1) This measure repeals Masaryk University Faculty of Pharmacy Measure No. 2/2021 "Determination of the Amount of Fees Associated with Studies for the Academic Year 2021/2022", effective from 1 September 2021.
- (2) I hereby delegate the interpretation of the individual provisions of this measure to the Vice-Deans responsible for the respective type of study in accordance with the Organizational Regulations of the Faculty of Pharmacy of Masaryk University.
- (3) Compliance with this measure is monitored by the Secretary of the Faculty.
- (4) This measure shall enter into force on the date of its publication.
- (5) This measure shall enter into force on 1 September 2022.
